Enemalta plc and IESC are dedicated to the preservation of the environment, health, and security of all individuals within their organisations, facilities and the surrounding communities. We seek to provide all necessary human and material resources to achieve the objectives of this policy.

As responsible entities, we aim to comply with all regulatory and legal requirements and to incorporate international best practices adopted by the industry in Europe and beyond. We commit ourselves to the principle of continuous improvement in the field of major hazard prevention through periodical reviews that assess our health and safety performance and the achievement of several pre-defined targets.
